- **I UNDERSTAND** that being able to drive and park my vehicle on the school grounds is a privilege accorded me by the school and that this privilege may be revoked at any time due to my failure to follow the rules and regulations pertaining to driving and parking on campus. In obtaining a parking permit, I am accepting full responsibility for the operation and parking of my vehicle on school grounds regardless of who is driving it.
- **I UNDERSTAND** and agree to abide by all regulations governing the operation and parking of my vehicle on school grounds. (Information concerning student driving and parking on school grounds is printed in the Parent Handbook under Driving and Parking Section. Additional rules appear on this contract. It is understood that by virtue of the fact that the student whose name appears below has a license to drive, they are fully cognizant of state and federal laws pertaining to the operation of a motor vehicle, when driving on property or to and from school events.)
- **I UNDERSTAND** that I can lose my driving privileges to and from school if I don't heed the following speed limits:
 - * On-campus – 5-10 mph.
 - * Between Mount Madonna Center (MMC) & Mount Madonna School (MMS) - 25 mph
 - * Between Mt. Madonna Road & MMC - 35 mph
 - * In Mount Madonna County Park is 20 mph
 - * On Mount Madonna Road (oceanside) - 15-20 mph (conditions and width of road permitting)
- **I UNDERSTAND** that when people are walking on the road (on the property) the speed limit is 5 mph.
- **I UNDERSTAND** that I must park in designated student areas and only in my assigned parking space, with a legitimate parking permit clearly displayed.
- **I UNDERSTAND** that I shall not move my car during school hours without specific permission from a faculty or staff member.
- **I UNDERSTAND** that I can only use Summit Road to drive to Lower Campus (during Play Intensive week) or to Hawk Nest Gym (for after school sports practice), **not** the emergency roads.
- **I UNDERSTAND** that I cannot claim ignorance of the law or school regulations pertaining to driving and parking should I be cited for failure to follow one or more of them.
- **I UNDERSTAND** that cars traveling uphill on mountain roads have the right of way. Yield to those driving up the hill.
- **I UNDERSTAND** at no time am I allowed to drive on any school sponsored field trip.

I understand that if I fail to adhere to the guidelines stated above, there may be consequences. These consequences will be determined by the Guidance Council and may include, but are limited to, the temporary loss of driving privileges.
